- All large company-related gatherings have been cancelled. These include gatherings at clients, other vendors or various stakeholders (NT/PT/AG) meetings.
- Access to Munsoft offices for non-Munsoft people are restricted.
- Our internal response plans around the safety of our staff, the capability to continue to conduct our work and most importantly, our ability to continue serving our clients in the best possible ways have been expanded and is continually revised and expanded.
- Munsoft will strive to continue to deliver our services, with a focus on remote delivery of work. We will be using telephonic, conference and video calls extensively.

The above measures will remain in place until further notice.

Even during this crisis time, the Munsoft team will continue to strive to make your organisation succeed.
